



**Transfer International Student Checklist (F-1 status)**

Thank you for your interest in Bevill State Community College. Please submit the following items and supporting documentation for potential enrollment at Bevill State Community College.

- Complete the online Bevill State Community College Application at [www.bscc.edu/students/apply-online](http://www.bscc.edu/students/apply-online)
- Schedule and take the College placement test.
  - Go to the following link and follow the procedures outlined: <https://www.bscc.edu/students/future-students>
  - If available, ACT/SAT scores should be submitted to the admissions office before taking the College placement test.
- Submit English Language Testing Scores. Minimum International TOEFL/IELTS scores accepted:
  - TOEFL: 500 paper based, 173 computer based, 61 internet based
  - IELTS: 5.5 (result copy must have photo and name)

**Note:** English as a Second Language exam may be waived for applicants who graduate from a U.S. high school, have earned a “B” or higher in a college-level (100 or above) composition course (must have been an in-person class, not online), or are a citizen or resident of an approved English-speaking country or region.

- Submit Financial Affidavit of Support Form. The Financial Affidavit of Support Form must be completed by each individual contributing financially to the student’s education. Official statement(s) from a financial institution documenting ability to pay costs of attendance must accompany the form. All estimates below are subject to change without notice.
  - Minimum of \$25,235 (USD)
  - If applicable, a minimum of \$3,028 (USD) is required for each additional dependent.
- Submit official documentation of secondary school completion and/or college transcripts.
  - Transfer students must have official transcripts from all previously attended colleges and universities issued directly to Bevill State Community College.
  - High school transcripts are required to be **translated** in English and **evaluated** for U.S. equivalency.
  - **Evaluations will only be accepted from NACES.org companies.** The following evaluation companies translate and evaluate high school and college documents:

- Submit a copy of your current I-20.
- Submit the F-1 Transfer Recommendation Form. (Form must be completed by your current PDSO/DSO)
- Submit copy of a valid visa and passport to include identification page, expiration date page, and visa page of passport.
- Submit copy of I-94 (front and back).
  - Electronic copies of the I-94 are acceptable from <https://i94.cbp.dhs.gov/I94/>.
- Submit proof of adequate health insurance.

***The College requires international students to have adequate health insurance which is inclusive of a repatriation benefit. Documentation of the proper insurance policy must be provided to the College prior to the issuance of the I-20 form.***

- Submit the following International Student Services Forms:
  - Financial Affidavit of Support Form
  - I-20 Student Information and Request Form
  - International Student Contact Information Form
- IMPORTANT NOTE!** There is no housing on the Bevill State Community College, Jasper campus. International students are responsible for procuring living and travel arrangements prior to arrival on campus.
